Policies regarding the Publication Award

The Publication Award will be handed on the following conditions:

1. The author who has published his/her original research articles and reviews in journals having an impact factor determined by Clavirate analytics and published in latest issue of Journal Citation Reports® will be considered for such publication awards.
2. The affiliation to Abasyn University, Peshawar in his/her paper by the claiming author is mandatory.
3. The award will only be handed to the claimant author (only one) who will submit the application for the award on the prescribed application form through respective Head of Department. The prescribed form will be available on the website of Abasyn University, Peshawar.
4. The first three authors in the author list would be eligible for the award
5. Only one author among the first three authors would be eligible for the award
6. The first author is entitled for full award (Rs. 10,000) while the second and third author would be entitled for 50 % award (Rs. 5000).
7. The Committee will meet once a month to consider the application requests, subject to receipt of such applications, and send their recommendations for the award to the Competent Authority through the Registrar, Abasyn University.
8. The application for the award will be papers published from **18th July, 2023 onwards**.
9. In case the M.Phil/MS or Ph.D. student is the first author of a research publication followed by his supervisor, then the supervisor (Abasyn faculty member) will be eligible for full award (Rs. 10,000)
10. In case of a false claim, the application will be rejected and the matter will be forwarded for appropriate disciplinary action.
11. The award will be recommended by the Research Award Committee after verification of impact factor from most recent edition of Journal Citation Reports® (JCR) / or HEC Journal recognition system (HEC JRS) in W and X Category journals only for all such requests and fulfillment of the following requirements:
 - a. Application on prescribed form

- b. First page of publication, clearly indicating the name and affiliation of claiming author
- c. Copy of the respective page of JCR clearly mentioning the journal name and its impact factor or a journal existing in the online portal (HEC JRS) in the W and X-category.


